Non-Refundable breeding fee of \$250 due with the contract. Balance of fees due prior to stallion being collected.

2019 Stud Fee: FIREWATER JET MOON (AQHA #5298041)

Fees include FIRST collection of stallion. All shipping and container costs must be paid by the mare owner directly to Monocacy Equine Associates.

**Agreement:**

I agree to breed the above stated mare to FIREWATER JET MOON, a.k.a "Chase" for the 2019 breeding season with the terms being as follows;

1. No mare will be bred until the contract has been completed, signed, and all fees have been paid.
2. All semen will be cooled and shipped from Monocacy Equine Veterinary Associates(301.607.4025). To receive the shipment you must contact MEVA and pay the shipping and container fees prior to collection and shipment. The container must be shipped back to MEVA at the mare owners expense.
3. A copy of the mare's papers must accompany this contract.
4. Breeding season goes from March 1<sup>st</sup>- June 30<sup>th</sup> . Accommodations will be made case by case.
5. IT IS THE MARE OWNER'S RESPONSIBILITY TO INFORM US OF MARE'S PREGNANCY STATUS! If we are not notified of mare's pregnancy status within 45 days post service, ANOTHER BOOKING FEE WILL BE DUE AND PAYABLE BEFORE RE-BREEDING THE MARE! If for any reason the mare does not become pregnant, we as the stallion owner/manager will NOT be liable.
6. We will issue an Breeders Certificate for each live foal born as a result of breeding services herein provided.
7. We live foal guarantee means that the foal is born alive, stands and nurses on its own, and remains alive for ONE WEEK. Please let us know within 72 hours of the death of any foal and a re-breed will be granted.

8. Should the mare miscarry, abort, or be barren, Mare Owner may re-breed the year immediately following. A substitute mare may be bred if the original mare is deemed unfit for breeding or dies.
10. If the mare needs to be rebred for a reason related to the mare (semen was shipped and she was not ready to breed, etc.) The mare owner will be responsible for additional collection fees for the stallion. The first collection is covered in the price of the stud fee.
9. If the stallion dies or becomes unfit for service, this contract is null and void and the stud fee less the booking fee shall be returned to the mare owner.
10. Mandy Rhinecker will NOT be liable for any sickness, accidents, or death to above mare or foal. Mare owner agrees that Mandy Rhinecker is not responsible for any negligence or errors, and that Mandy Rhinecker may use her own judgment in supervising mares. Mandy Rhinecker assumes no liability to mare owners.
11. Any dispute of this contract will be governed by the laws of the State of Maryland and venue of any dispute arising from this contract will be in Frederick County, MD.
